How do we collect information from you?

We obtain information about you when you apply for a job through our online system.

What type of information is collected from you?

The personal information we collect will include your name, address, email address, CV and cover letter and also your answers to the application form. During the application process, we will also collect correspondence between you and Frontier Agriculture, test results, interview results and feedback gathered through the recruitment process.

How is your information used?

We will use your information to:

- process your application and provide a high quality service to you;
- contact you to update you on the recruitment process;
- arrange recruitment tests if required;
- provide Frontier Agriculture information to decide on whether you are successful in your job application;
- if successful, create a contract of employment and offer letter.

How is your information retained?

We review our retention periods for personal information on a regular basis. We are legally required to hold some types of information to fulfil our statutory obligations. If you are unsuccessful, your information and online account will be deleted within 12 months of communication to explain the result of the application (unless you are progressing through another application at the same time).

Who has access to your information?

We will not sell your information to third parties.

We will not share your information with third parties for marketing purposes.

Your information will only be shared within Frontier for the purposes of the recruitment process.

Your information may be shared with our Recruitment System (Halogen Software) provider for the purposes of resolving technical difficulties and once fixed, will be permanently deleted from their systems.
